- \* Inspections - Some state inspection requirements use both government inspectors and 3rd party inspectors.
- \* AZ provides public records of accidents only for trampoline court injuries
- \* CA requirement to report equip malfunction applies only to portable rides
- \* CO requires reporting of injuries, but only if the accident was caused by a ride malfunction or impairs the function of the ride/device.
- \* DE inspection at each setup is for electrical only
- \* IA, IL waterslides are regulated by a different agency under different rules (Dept. of Public Health)
- \* KY Injuries must only be reported if they result from a ride/device failure
- \* LA inflatables must be inspected at each setup, but the owner/operator can self-inspect if approved by the state
- \* MD bungee jumping is prohibited by state law
- \* MN only regulates inflatables at permanent indoor facilities open to the public
- \* MO regulation of inflatables is restricted to slides > 20' high

\* NC, WA waterslides are regulated by a different agency under different rules (Dept. of Public Health). PA splits oversight across 2 agencies.

\* ND - No inspection frequency was specified in statute/regs; assume annual

\* NV, SD, UT - Patron responsibility law applies only to amusement park rides, not carnival (portable) rides.

\* NY - State law exempts rides/devices operated in NYC and other cities > 1 million people; accidents are investigated by a safety coordinator designated by the park/carnival

\* OH - Re-inspection after accident vs. investigation

\* SD - Fixed-site rides are exempt from inspection requirement; Portable rides are exempt from Patron Responsibility requirement

\* WA - Inspection at each setup is for electrical only
